**Stipulation and Order of Dismissal**

IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned, counsel for Plaintiff Verizon New York Inc.; Plaintiff Long Island Lighting Company d/b/a LIPA; and Defendant Town of Southampton (each a "Party" and collectively, the "Settling Parties") as follows:

1. All claims against Defendant Town of Southampton are dismissed in accordance with the Stipulation of Settlement filed herein on September 9, 2015 (ECF No. 156-1);
2. The dismissal is without costs between or among the Settling Parties, including attorneys' fees and expenses;
3. The Settling Parties jointly request that this Stipulation be so ordered;
4. The Settling Parties further stipulate and agree that the Court shall retain jurisdiction with respect to any and all issues or disputes that may arise in connection with the Settling Parties' settlement.

This Stipulation shall have no effect on Plaintiffs' remaining claims against other defendants in this action, which remain pending.
